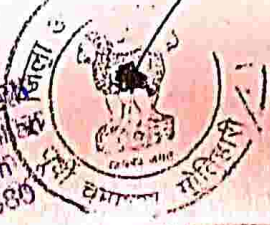

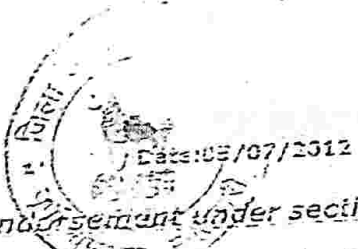

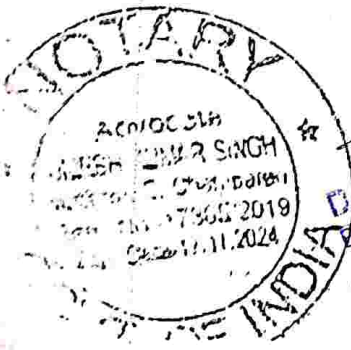
Board of Trust unanimously accepted the resignation tender by three trust members and unanimously added following four persons as new trustees.

Resolution dated 28/05/2022 all the trust members unanimously decided that following powers, functions, terms and conditions, along with amendments in deed serial no. 12508, Deed stamp no-290, Book No- 04 Page No 68 to 75 , CD NO - 2 on dated- 05/07/2012 are hereby incorporated in the trust deed which shall be applicable for all the trustees.

01. The trust will have the office of Chairman/President and Vice Chairman/Vice-President.
02. A trust member may be removed by resolution passed by at least three trust members which may also include Chairman/President, being one of the trustees.
03. The tenure of office bearers of the trust will be five years. After the completion of five years the new office bearers will be elected by mutually agreed consent of at four trust members which may also include Chairman/President( being one of the trustees).
04. The bank account of the trust and the school run by the trust will be open and operated jointly by the Chairman/President and any one trustee.
05. All decisions to be taken against work defined in Deed stamp no- 290, Book No- 04 Page No. 68 to 75 , CD NO - 2 on dated- 05/07/2012 including those which involves or does not involve financial implications and any other such work, on mutually agreed consent of at least Three trust members which may also include President being one of the trustees.

**The office bearers' power and functions are as follows**

**THE CHAIRMAN/PRESIDENT** shall be the chief functionary of the trust and shall be responsible for the following functions:-

- (i) He will be head of the Board of Trustees of the Trust and preside over all the meetings.
- (ii) He may advise the Vice-President to call a meeting of the Board of Trustees.
- (iii) To establish contract, negotiate and conclude contract, arrangements etc. with outside agencies taking assignments, projects and other works for and on behalf of the trust with the advice of Chairman.
- (iv) To keep a record of the proceeding of the founder trustees, board of trustees, general meeting.
- (v) To maintain a register of trustees/members with such particulars as may be determined by the board of trustees.
- (vi) To carry on correspondence on behalf of the trust and to have in custody the records and files of the trust.
- (vii) To execute the policy of the trust.
